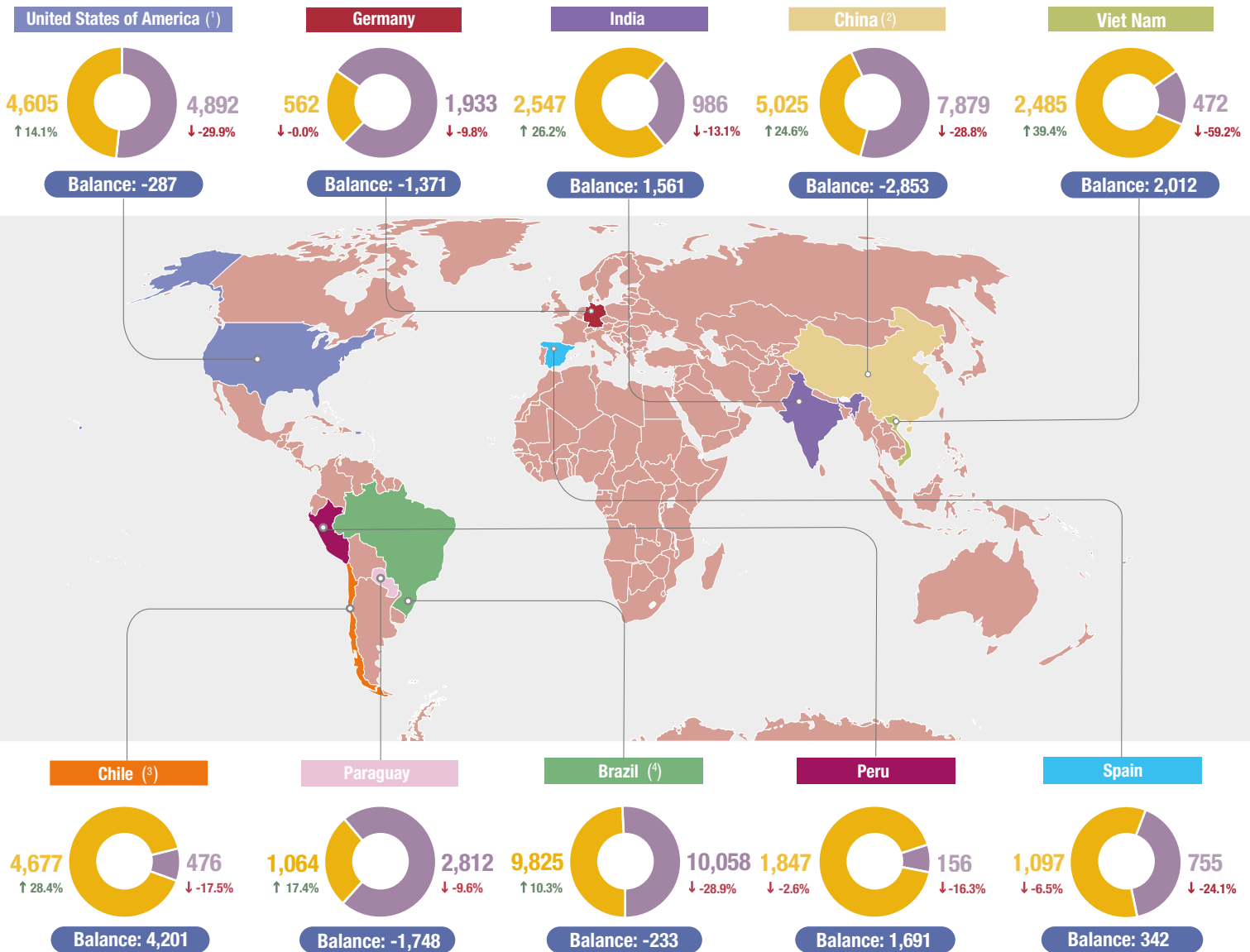

Introduction

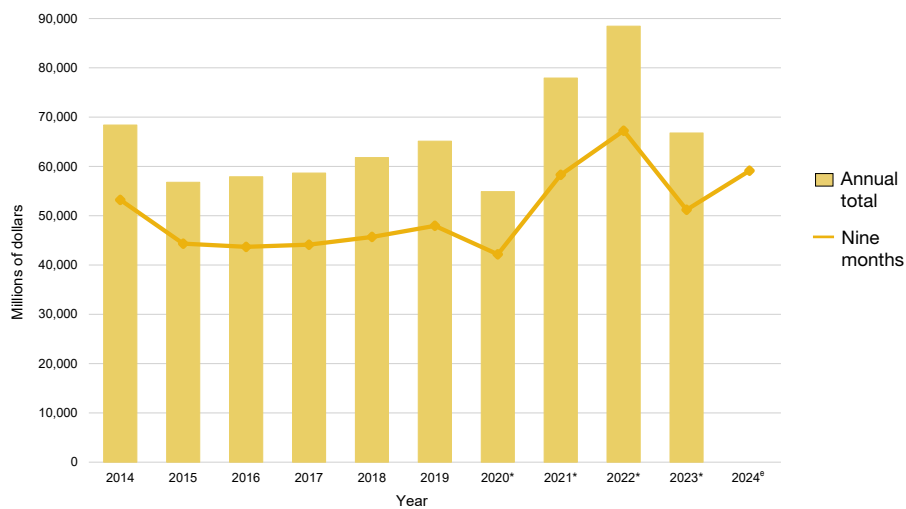
The National Institute of Statistics and Censuses (INDEC) presents the Argentine Foreign Trade Statistics publication with the aim of disseminating information on merchandise exports and imports classified by country.

This publication has been prepared to concisely describe Argentine foreign trade and provide up to date information to the global community, by main economic areas and by sections, chapters and subheadings of the Harmonized System 2022 code

This publication is available on a quarterly basis: in February, May, August, and November. This edition includes data for the nine months of 2023* and 2024*.

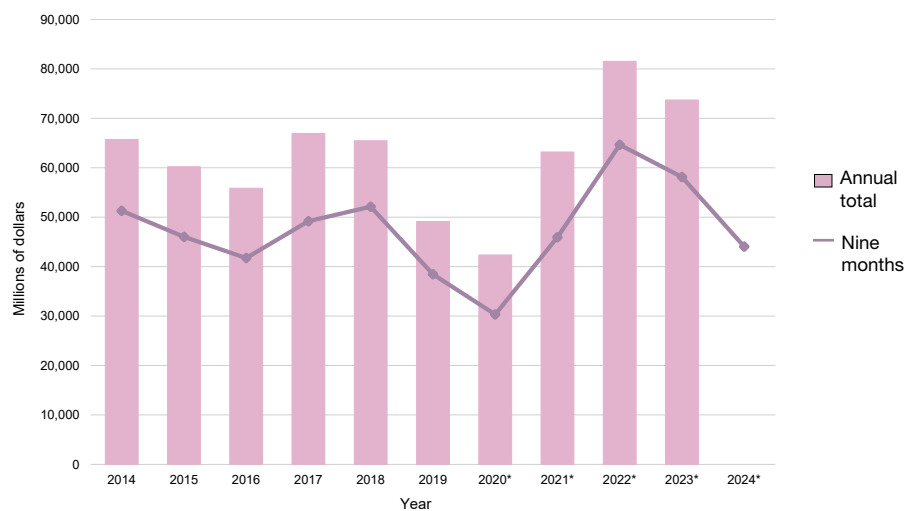
Graph 1. Exports, in millions of US dollars, 2014-2023 and nine months of 2014-2024

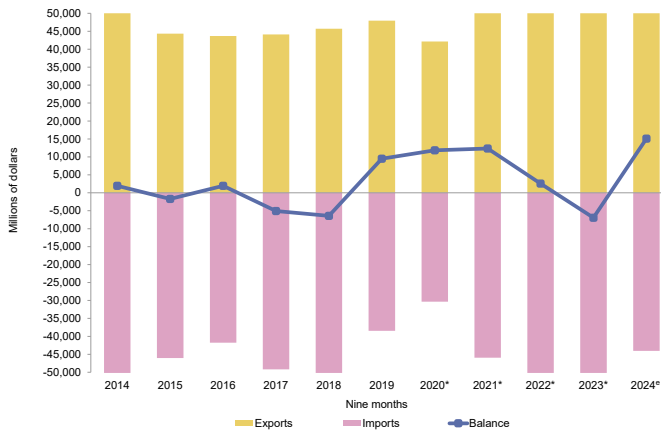

Overview

For the nine months of 2024, Argentina's merchandise exports increased by 15.5% and reached 59,124 million US dollars, while its merchandise imports decreased by 24.2% and reached 44,049 million US dollars. The merchandise trade balance recorded a surplus of 15,075 million US dollars.

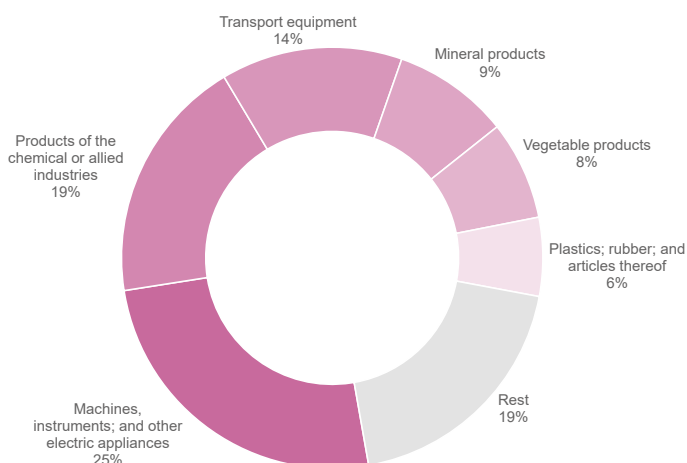
Exports profile

For the nine months of 2024, the top five HS sections for merchandise exports were Vegetable products (section II); Foodstuffs; beverages; tobacco and its manufactures (section IV); Mineral products (section V); Transport equipment (section XVII); and Animal or vegetable fats and oils (section III); representing respectively 22%, 19%, 11%, 10%, and 9% of exported goods (See Table 4).

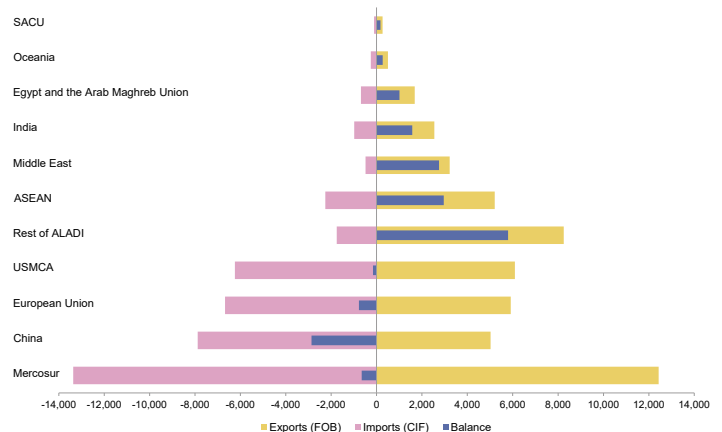
The five largest export commodities were Oilcake and other solid residues, whether or not ground or in the form of pellets, resulting from the extraction of soya-bean oil (230400); Maize (excluding seed for sowing) (100590); Petroleum oils and oils obtained from bituminous minerals, crude (270900); Crude soya-bean oil, whether or not degummed (150710); and Motor vehicles for the transport of goods, with compression-ignition internal combustion piston engine (diesel or semi-diesel) of a gross vehicle weight <= 5 t (870421) (See Table 6).

In addition, the top five destinations for merchandise exports were Brazil, China, Chile, United States of America, and India, accounting respectively for 17%, 8%, 8%, 8% and 4% of total exports (See Table 2).

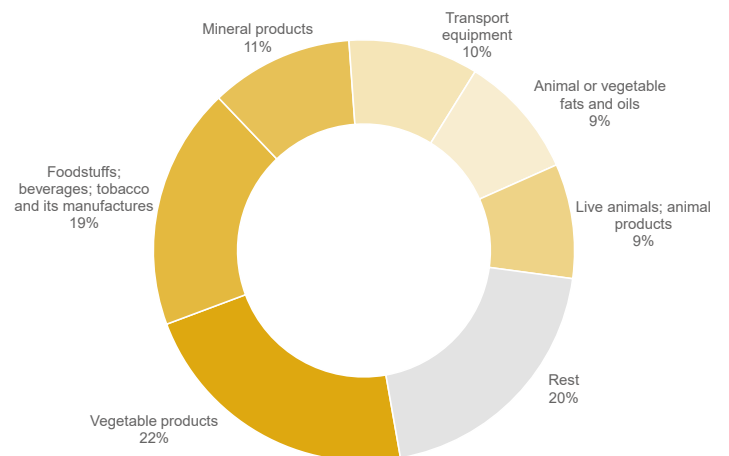
Graph 6. Imports by sections of the Harmonized System (HS) code, percentage share, for the first nine months of 2024

Imports profile

For the nine months of 2024, the top five HS sections for merchandise imports were Machines, instruments, and other electric appliances (section XVI); Products of the chemical or allied industries (section VI); Transport equipment (section XVII); Mineral products (section V); and Vegetable products (section II); representing respectively 25%, 19%, 14%, 9%, and 8% of imported goods (See Table 4).

Moreover, some of the most-imported products include Soya beans, whether or not broken (excluding seed for sowing) (120190); Medium oils and preparations of petroleum or bituminous minerals, not containing biodiesel, n.e.s. (271019); Motor vehicles principally designed for the transport of <10 persons, of capacity > 1,500 cm³ but <= 3,000 cm³ (870323); Natural gas, liquefied (271111); and Gear boxes and parts thereof, for motor vehicles of headings 8701 to 8705 (870840) (See Table 7).

The top five partners for merchandise imports were Brazil, China, United States of America, Paraguay and Germany, accounting for 23%, 18%, 11%, 6% and 4% of total imports, respectively (See Table 2).
